

In order to meet our goal of achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 43.125 tCO2e by 2028. This is a reduction of 25%.

## **Carbon Reduction Projects**

#### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes will be reviewed in December 2024 and measures will be in effect when performing the contract

Hammersmith and Fulham Association for Mental Health (Known as Hammersmith, Fulham, Ealing and Hounslow Mind) has a commitment to reducing our carbon impact. We already provide numerous initiatives to reduce our impact, which include:

- **Remote Working**: We offer home-working options to staff where feasible, reducing commuting emissions.
- **Virtual Collaboration**: We use platforms like Microsoft Teams to cut down on travel.
- Recycling Programs: We offer comprehensive recycling facilities across all sites.
- **Energy Conservation**: We encourage staff to power off equipment when not in use.
- **Sustainable Transportation**: All locations are accessible by public transport, and bike storage is available.
- **Responsible Taxi Use**: Taxi use is strictly regulated to ensure it's only used when necessary.
- Cycle to work scheme: We have a cycle to work scheme to reduce

In the future we hope to implement further measures such as:

- **Energy Efficiency Upgrades**: We will consider energy efficiency upgrades to our sites wherever practical (e.g. replacing conventional lighting with energy-efficient LED bulbs where this hasn't already been done).
- **Enhanced Staff Engagement**: Our staff Environmental Champions group will recruit more members to ensure widespread participation.
- **Staff training**: Our Environmental Champions plan a programme of staff-training to reduce their carbon emissions in the workplace and when working from home.
- Local and Ethical Procurement: We will conduct a review of procurement processes to prioritise local suppliers and assess the environmental impact of purchases.
- **Sustainable office supplies**: We will aim to purchase made office supplies and eliminate single-use items where possible.
- **Green Energy**: We will explore switching to green energy suppliers at our sites.
- Carbon Offsetting: We will look to carbon offsetting by engaging with organisations that will plant and look after trees for us in protected Nature Reserves. Currently this would be 863 trees.
